# ENCePP Partners Survey - Background

## Why?

Feedback received from previous ENCePP Plenary meetings suggested that it might be time for a re-think:

- It was felt that the agenda was too procedural and EMA-driven with insufficient time for scientific discussion.
- Heavy agendas did not provide enough networking opportunities.

Results from the survey could serve as a starting point to reflect on the motivation of ENCePP partners and ways to **improve participation** in general, and in particular to **re-consider the structure and content of the ENCePP plenary meetings**.

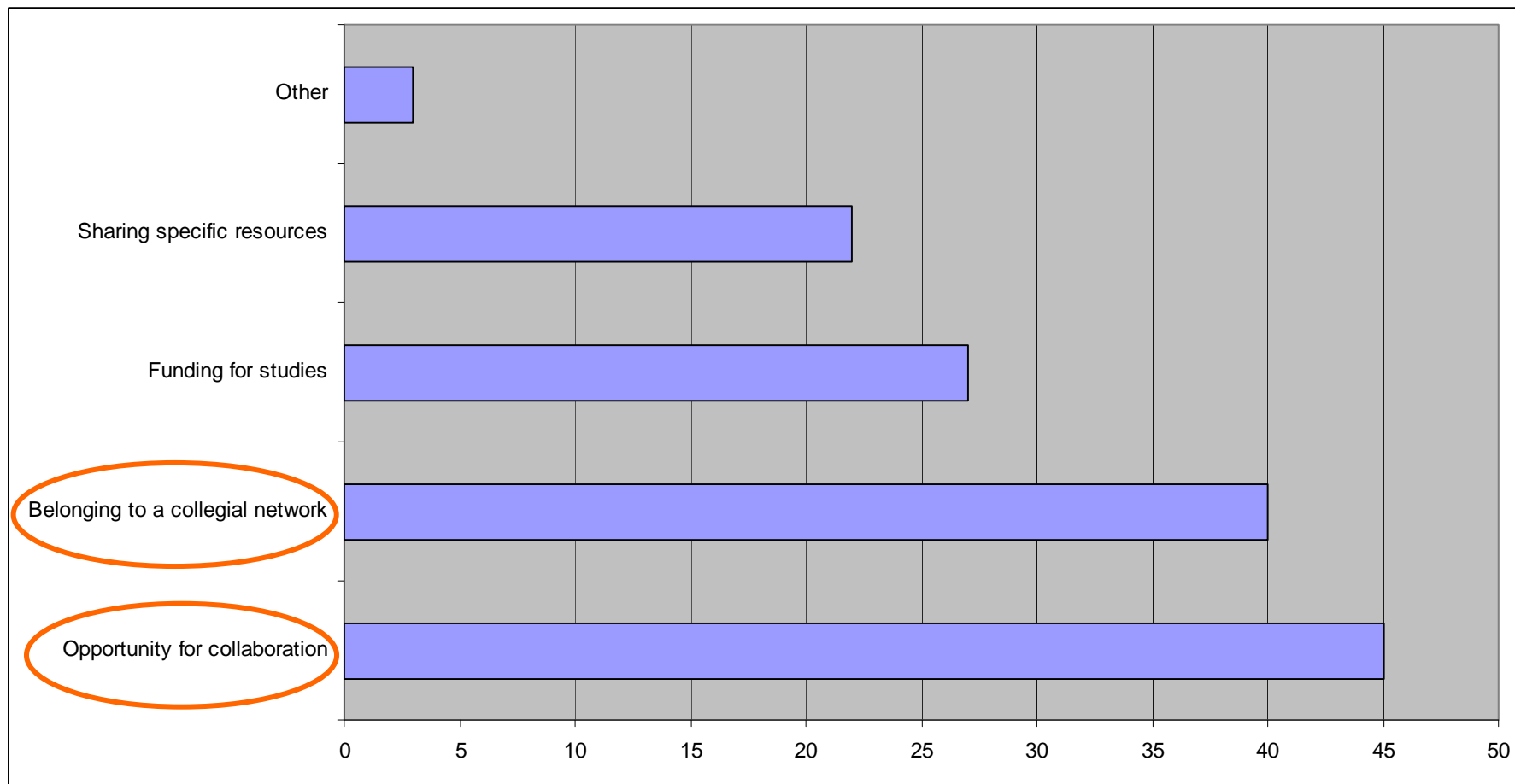

# Q1: Motivations behind joining ENCePP?



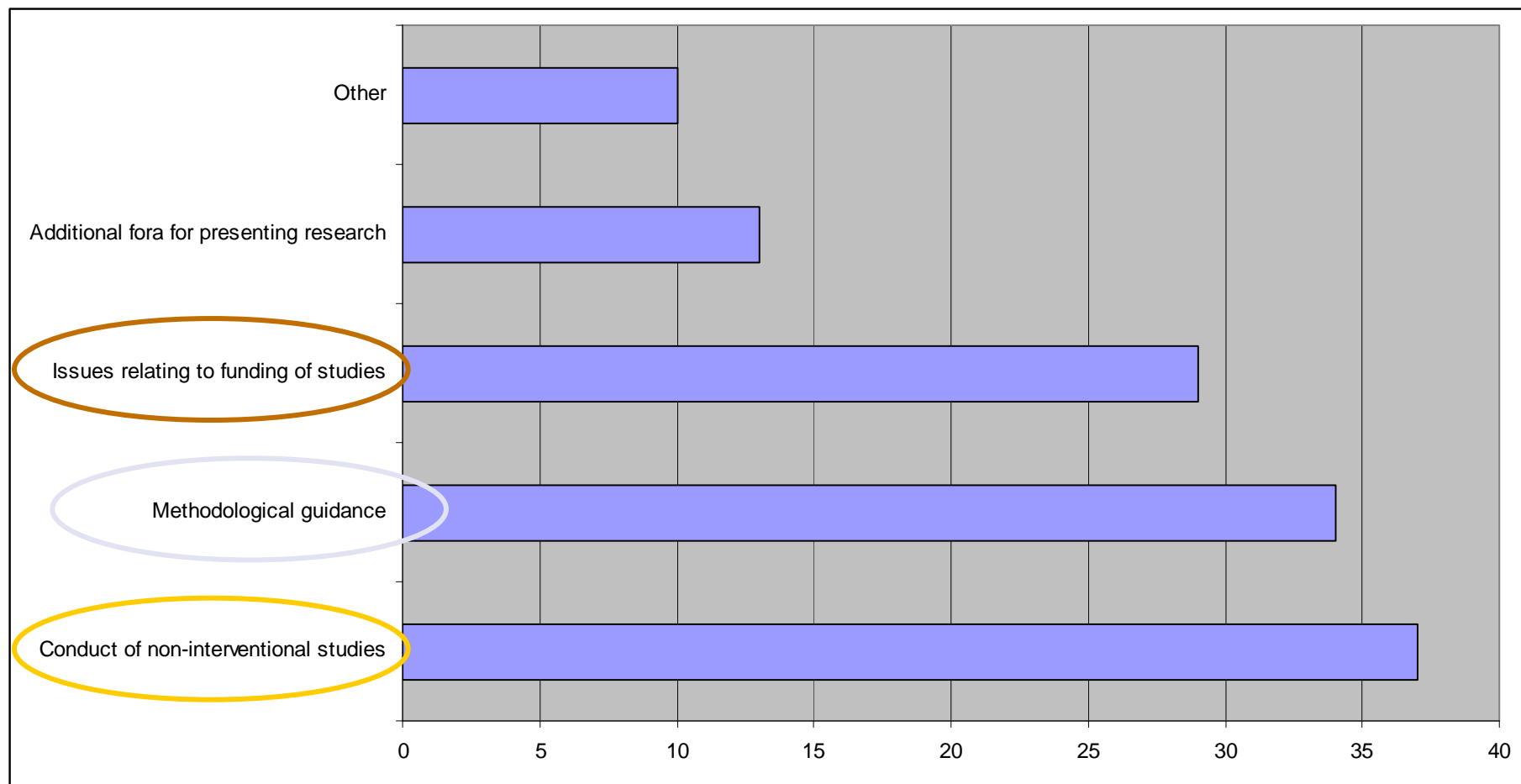


## Q1: Motivations behind joining ENCePP?

- Majority of partners responded that their expectations have been met since joining the network.
- Positive feedback highlighted involvement in working groups or other specific tasks and the opportunity given by ENCePP to contribute with own ideas to the development of the project.
- Some dissatisfaction is due to the fact that the initiative is being perceived as imbalanced between an EMA and academic agenda and lacking in practical activities that would enhance collaboration between centres.

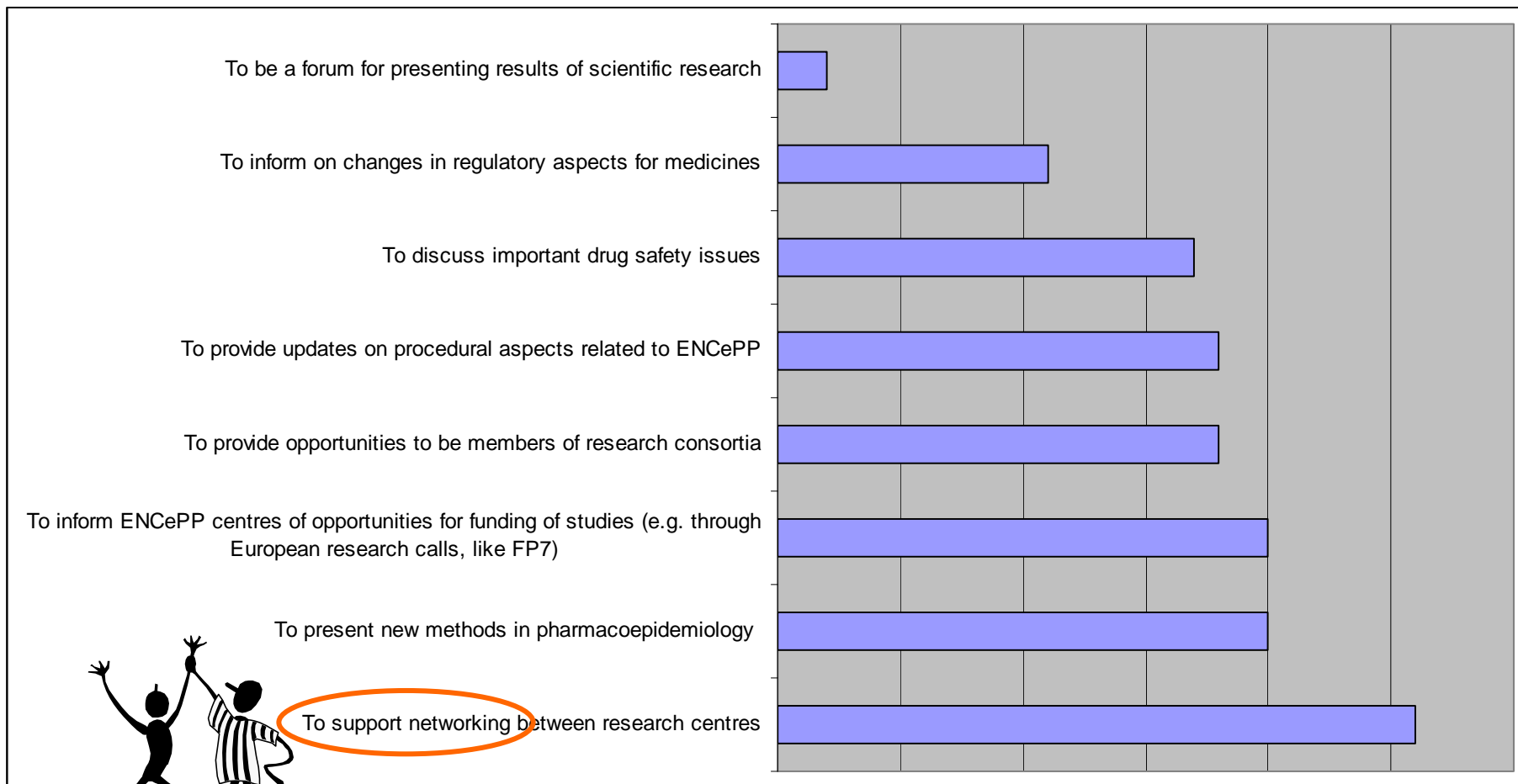


## Q2: Priorities for ENCePP?

To support networking between research centres

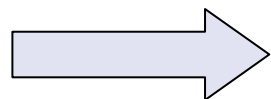




## Q4: Research topics to be included in public funding programmes

More than 40 research topics have been suggested, ranging from purely methodological topics to specific adverse reactions of interest, special populations or safety of particular drugs or class of drugs.

## Q5: Contribution of ENCePP partners to the ENCePP Plenary

ENCEPP partners were asked whether they would be willing to **contribute to the ENCePP Plenary** in terms of presenting or joining a discussion panel.

**More than half** of the respondents replied **positively**, and a number of proposals were received, ranging from suggestions on methodological topics, examples of collaborations between centres to results of research conducted.

- Proposals for contributions to the Plenary meetings have been taken into consideration already for this Plenary agenda, while others will be carried over to future Plenary meetings.
- Closer involvement of Steering Group in development of Plenary agenda.
- Meetings of the three existing working groups have been scheduled in the margins of the next ENCePP Plenary meeting.
- Coffee and lunch breaks have been extended.
- New seating plan.



## Agreed Actions



- To involve partners more actively, the working groups need to be activated and group discussions encouraged.
- Priorities and preferences identified by ENCePP partners which will be taken into consideration in future planning of ENCePP activities.
- Obtain feedback from the Plenary on the interaction with industry.
- Research topics to be grouped and presented to the Plenary for discussion on how to make best use of this information and agree on the next steps.
